Primary Exempt Purpose

PEOI offers online professional education to over 7,500 registered students and several times that many unregistered students in 2009 with the help of over 4,500 volunteers. Volunteer work in 2009 exceeded 82,400 hours for a dollar equivalent of \$1,440,000. Similar amounts were shown as capitalized course development prior to 2006. But PA Bureau of Charitable Organizations asked that this amount NOT be reported as revenue to PEOI.
